#### The Organisation

##### The National Cancer Registry

The National Cancer Registry (“NCRI”) was established by the Minister for Health in 1991 by Statutory Instrument and is primarily funded by the Department of Health. It was set up to record information and provide independent insights on all cancer cases occurring in Ireland and has been collecting such data since 1994. NCRI is an essential part of Ireland’s efforts to successfully control cancer, reducing its impact on individuals, families, and society. We are the key organisation in understanding cancer incidence, prevalence, and survival rates in Ireland, reflecting demographic changes and new diagnostic and treatment options.

##### University College Cork

University College Cork is ranked in the top 1.1% of universities in the world. It is Ireland’s leading institution for the delivery of research impact and the top Irish institution for highly cited researchers. We are the leading global university for sustainability and the Irish university with the highest level of industry collaboration. The UCC School of Public Health has close links including joint appointments with the National Cancer Registry and the National Suicide Research Foundation. The School of Epidemiology & Public Health is one of the founding members (with the Royal College of Surgeons and Trinity College Dublin) of the Irish Health Services Research Consortium.

#### The Role

The Head of Research and Analysis will play a key role within the NCRI, with responsibility for the overall strategic leadership and management of the NCRI Research and Analysis Department. The post-holder will be responsible for coordinating, managing, and delivering a high impact research and surveillance programme within the area of Cancer Epidemiology and consistent with the statutory and strategic aims of the organisation.

In addition, the post will incorporate a role as Senior Lecturer of Cancer Epidemiology in the School of Public Health at University College Cork. The post-holder will be expected to contribute to the consolidation and further development of the School of Public Health’s research activities, working as necessary with colleagues in cognate disciplines in the school and the wider University. The post holder will also be expected to undertake some teaching and supervisory activities at both undergraduate and postgraduate level and to also supervise a small number of postgraduate students.

#### The Person

The successful applicant will have experience in epidemiology, statistics, health services/health science research or a similar/related subject. They will have a strong history of delivering high quality research projects, on time and within budget, with a record of success in securing substantial grant funding, ideally having been Principal Investigator on at least one major successful research applications.

The role will also require a person who has experience of participation in relevant academic and professional associations/ bodies as appropriate, with a proven track record of the ability to participate in and contribute to the overall intellectual life of the University, the academic discipline and society at large. They must also have excellent interpersonal and communication skills, with the ability to present, explain and interpret data or analysis to non-technical audiences
